3. To take a position on proposed legislation or policy direction affecting the _____ and _____ mem

1. Active city, county, special district (transportation agency (transportation authorities, congestion management, etc.), joint powers authority, regional agency (directors, assistant/deputy directors, planning directors), private planning consulting firms, owners or operators in the San Francisco Bay Area.
2. Membership shall become effective upon the acceptance of an eligible member. Membership shall automatically terminate upon the effective date of resignation, termination, or position cited in the bylaws.
3. There are no membership dues. Any costs to the Association shall be in the form of registration fees for Association members. The Association shall, under economic conditions in the region and of its resources, endeavor to have the Association to completely cover its costs for meeting room, food, speakers, notification, and other expenses.
