1. To provide professional education, advice, support and leadership on planning policy and practice at the state, regional and local level;
2. To foster the exchange of ideas, information and best practices among Bay Area planners;
3. To take a position on proposed legislation or policy direction affecting the \_\_\_\_\_ and \_\_\_\_\_ mem

1. Active city, county, special district (transportation agency (transportation authorities, congestion management, etc.), joint powers authority, regional agency (directors, assistant/deputy directors, planning consultants, private planning consulting firms, owners or operators) in the San Francisco Bay Area.
2. Membership shall become effective upon the acceptance of an eligible member. Membership shall automatically terminate upon the effective date of resignation, termination, or position cited in the bylaws.
3. There are no membership dues. Any costs to the Association shall be in the form of registration fees for Association members. In times of economic conditions in the region and of its members, the Association shall endeavor to completely cover its costs for meeting room, food, speakers, notification, and other expenses.
